Career Opportunities in the Industry

This qualification addresses work in residential facilities and/or in community agencies and day centers and work under professional supervision within defined organisation guidelines or as sole practitioners

Hays offers a range of activities in conjunction with St Theresa's Aged Retirement Services (STARS) who come to all functions and planned activities held by the Leisure and Health students. This regular event can range from all day Multicultural Events, to short lifestyle activities, to exercise class and lunch. This group of 30 Aged Clients with 10 volunteers also host functions which students from Hays attend – including Leisure and Health week activities eg. Aquarium visit, where students support Leisure and Health peoples living in the community in a safe and equable manner.

Entry requirements

- Completion of Australian Secondary (Year 12) education or equivalent for Certificate III courses.
- Proficiency in English – Minimum IELTS overall band score of 5.5 or equivalent
 - Have completed a Certificate III, Certificate IV, Diploma or Advanced Diploma level Training Package course in Australia.
- Above 18 years of age.

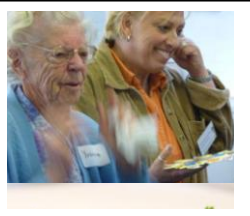

This program is delivered in a classroom based environment with access to a Practical aged care lab for practical components of the course. In addition students will also be required to undertake a practical placement in a workplace environment under supervision to ensure the student can perform the work as expressed in each unit of competency. Each unit is delivered and assessed as a standalone unit. This program also contains an e-learning component to consolidate their learning.
